NOTICE OF RACE

1. RULES

- 1.1. The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS). To the extent permitted by Part 7 of the RRS, specific provisions of the rules may be modified, altered or made inoperative by the Notice of Race (NOR) or the Sailing Instructions (SI).
- 1.2. Changes to the Racing Rules and/or Class Rules will appear in full in the Sailing Instructions. The Sailing Instructions may also change other Racing Rules.
- 1.3. If there is a conflict between languages the English text will take precedence.

2. ADVERTISING.

- 2.1. Boats may be required to display advertising chosen and supplied by the organizing authority.

3. ELIGIBILITY AND ENTRY

- 3.1. The event is for boats of the Laser, Optimist, Sunfish Class and is open to all sailors.
- 3.2. All skippers must be a current member of the appropriate class association; (RRS75.2 Competitors shall comply with ISAF Regulation 19, Eligibility Code).

- 3.3. If you are not a current member of the class association, membership to the association will be available for a nominal fee.
- 3.4. Participants may enter by completing the registration at the Escuela Deportiva de Vela de Carolina, Saturday June 7 from 9:00am – 10:30am & Sunday June 8 from 8:30am-10:00am.

4. FEES

- 4.1. \$25 Registration for Sunfish class only on Saturday June 7 will includes Class dues and \$15.00 for Saturday evening BBQ, additional tickets will be available.
- 4.2. Entry fee includes event registration and snacks for competitors.

5. REGISTRATION

- 5.1. Participants may enter by completing the Registration, Optimists and Laser 4.7 will register and race on Sunday June 8 only.

To constitute a series one (1) races must be sailed. A minimum of 5 races should be completed in order to allow one throw out in the series. Multiple races will be run as time and weather conditions permit. No races will be started after 3:00pm on Sunday.

The CAC classificatory series will be governed by the previously publish NOR and amendments for the event.

responsibility for the nautical qualities of their vessels, the rigging, the crew's ability and the safety equipment. Competitors also agree to take any and all responsibility for damages caused to third persons (bodily injury included but not limited thereto) or their belongings, to themselves (bodily injury included but not limited thereto) or to their belongings, ashore and at sea as a consequence of their participation in the regatta, relieving of any responsibility The Puerto Rico Sunfish Class, the Federación de Vela de Puerto Rico, the Gobierno de Puerto Rico and its Departamento de Recreación y Deportes (DRD), Escuela de Vela de Carolina, Municipio de Carolina, or their sponsors, and all persons involved in the organization under whatever qualification. Competitors are to be acquainted with ISAF RRS Part 1 Fundamental Rule 4: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone". In any case, competitors agree that the afore mentioned organizations or governmental entities, their sponsors, and all persons involved in the organization under whatever qualification, the sponsors and their agents, have no responsibility for loss of life or injury to members or others or for the loss of, or damage to any vessel or property. As part of the registration process, all individuals and participating crewmembers will be required to sign the disclaimer of liability..

All competitors and their parents/guardians, before end of registration, must sign a waiver.
